Subject: Assessment and Certification of trainees for PIAs of project 2018-19 & 2019-20-reg.

Madam/Sir,

The under signed is directed to inform that, for the target year 2018-19 and onwards, all PIAs are advised to get assessments of their trainees done preferably from respective SSCs. However, in case the trainees are got assessed by the listed awarding bodies of NCVET, (as per Annexure attached), the onus and responsibility shall lie on the PIAs to carefully satisfy themselves about the sectoral & geographical jurisdiction bestowed by NCVET on that particular awarding body.

2. Assessments and assessment certificates issued by Third Party Agencies or any assessing agency, other than the list of organisations circulated and approved by MSDE shall not be admissible for release of grants.
3. The PIAs should carefully satisfy themselves about the validity of affiliation of the awarding bodies with NCVET, other than SSCs from time to time, in future prior to getting assessments of the trainees done and getting the assessment certificates issued.
4. This is issued with the approval of the competent authority.
