**Sub: Release of grants-in-aid (2<sup>nd</sup> and 3<sup>rd</sup> Installment)  
to PIAs under Seekho aur Kamao Scheme for the  
Project Year 2017-18 and 2018-19**

Sir,

I am directed to say that this Ministry allotted/sanctioned Projects to Programme Implementing Agencies (PIAs) for providing skill training to minority youths for the Project Year 2017-18 and 2018-19. The first installment of the Project Cost and stipend was released after allocation and submission of requisite documents.

2. The Ministry is making efforts to help release second and third instalments of the Projects at the earliest. PIAs have

been requested to update the data of all pending installments on Seekho aur Kamao (SAK) Portal in the past, many times. They were also apprised that release of grants would be decided by First in First Out basis. These instructions were reiterated vide this Ministry's letter No.SAK-15011/21/2021-SAK-MoMA dated 18th May, 2021 with the request to furnish information in the prescribed Format and upload data on SAK Portal. Furthermore, Ministry has contacted PIAs through several Video Conferences, to know their problems/issues in uploading data on SAK Portal and in submission of proposals for release of funds. Many PIAs have however still not complied with the directions/instructions and have not uploaded data for releasing 2<sup>nd</sup> and 3<sup>rd</sup> instalments for the Project Year 2017-18 & 2018-19, so far.

**3. In view of the above, it has been decided to provide one last opportunity to PIAs to upload/furnish complete data and requisite documents for claiming 2nd/3rd installments for the Project Year 2017-18 & 2018-19 immediately latest by 30<sup>th</sup> March 2022, failing which necessary action to cancel the Project and recover the funds (with interest) already released in accordance with the guidelines of Government of India will be initiated. Such PIA's shall also be liable to be debarred from further empanelment with the Ministry and blacklisting.**

4. This issues with the approval of competent authority.
